B Under the EAJA, 28 U.S.C. § 2412(d)(1)(B), a prevailing party is entitled to an award of reasonable attorney fees, costs, and expenses in any civil action brought by or against the United States unless the court -4- finds that the position of the United States was substantially justified or that special circumstances make an award unjust. The burden of proving that the government was not substantially justified in defending the action lies with the party challenging the government's position. See Roberts v. Chater, 99 F.3d 626, 631 (8th Cir. 1996). A position is substantially justified if there is a reasonable basis in truth for the facts asserted. See Adams v. Barnhart, 237 F.3d 934, 938 (8th Cir. 2001) (citing Pierce v. Underwood, 487 U.S. 552, 565 (1988)).
