What kind of processing do you have to do after I send them the NOA? Yes, I received no notice of appeal from them. I also received NOA from Ombudsman. I do not know where to go next. I was in same situation as you. We did not receive any

notice from USCIS. We did not hear anything since we filed our I-485. We did not get any NOA from Ombudsman. Its just to inform you to file the appeal on CSC website. You need to file an appeal on CSC web page with the NOA. In our case, it was USCIS issued NOA. I guess you will need to email your CA state office of your current employer, and request them to send NOA on your behalf. I have I-485 filed a few years back and was able to get E
