in addition to any other penalties provided by law, and except as provided in subsection (d) of this section, a person is disqualified from operating a commercial motor vehicle for one year if convicted of a violation of (1) operating any motor vehicle while under the influence of intoxicating liquor or drugs, or both, under section 14-227a, (2) operating a commercial motor vehicle while having a blood alcohol concentration of four-hundredths of one per cent, or more, (3) evasion of responsibility under section 14-224, (4) using any motor vehicle in the commission of any felony, as defined in section 14-1, (5) operating a commercial motor vehicle while the operator's commercial driver's license is revoked, suspended or cancelled, or while the operator is disqualified from operating a commercial motor vehicle, (6) section 14-227m, or (7) subdivision (1) or (2) of subsection (a) of section 14-227n. in addition to any other penalties provided by law, and except as provided in subsection (d) of this section, a person is disqualified from operating a commercial motor vehicle for a period of not more than two years if convicted of one violation of causing a fatality through the negligent or reckless operation of a commercial motor vehicle, as evidenced by a conviction of a violation of section 14-222a, 53a-56b, 53a-57 or 53a-60d. the disqualification periods in this subsection shall also apply to convictions under the provisions of law of another state, of offenses deemed by the commissioner to be substantially similar to the offenses described in this subsection. sec. 14-46g. motor vehicle driver training program. there is hereby created the driver training program for persons with disabilities which shall consist of a program of instruction of the department, a program of instruction of the department and the board jointly.

sec. 14-72. restrictions on operation of drivers' schools. (a) no school may operate or maintain a drivers' school unless the school has been granted a permit from the commissioner. a permit shall be granted only upon receipt of an application therefor. (b) upon receipt of an application for a permit, the commissioner shall determine whether the information set forth in the application is complete and accurate. if the information is incomplete and/or inaccurate the commissioner may reject the application. (c) a permit shall be granted only to a school that meets the criteria established in regulations of the commissioner, and those criteria shall include but not be limited to, the following: (1) the school shall be owned and operated by the school and its principals; (2) the school shall be located in an area contiguous to a major highway, in a state highway district or in a city or town that is adjacent to a major highway and has a population of at least 5,000; (3) the school shall be operated in a manner which is consistent with the standards of the department of public safety; (4) the school shall be operated by an individual or organization that is responsible for the safety of the students; (5) the school shall not be affiliated with a drivers' school which is authorized to operate in this state and which meets the criteria established in regulations of the commissioner; (6) the school shall be located at least 100 feet from any school and at least 50 feet from any stop sign or traffic control signal. (d) the commissioner shall establish regulations for the issuance of permits and those regulations shall include but not be limited to, the following: (1) the number and location of permit holders may not exceed the number and location approved by the state. (2) the commissioner may require a permit holder to maintain a qualified, licensed individual who is responsible for the safety of the school and the students. the responsibilities of such a qualified, licensed individual shall include but not be limited to, teaching and instructing the students in the safe operation of motor vehicles. (3) permit holders shall be responsible for the maintenance of the school premises, the classroom and all equipment used in the operation of the school. (4) permit holders shall be responsible for the monitoring of the school. (5) permit holders shall be responsible for the records of the school. (6) permit holders shall be responsible for the safety of all students participating in the school. (7) the school shall be inspected at least once a year by the commissioner. the commissioner shall establish the frequency of inspections. (e) the commissioner shall establish written standards for the issuance and revocation of permits. (f) the commissioner shall establish a program of insurance for the protection of the students, permit holders and the public. (g) the provisions of this section shall not apply to schools which operate in accordance with the provisions of section 14-120, except that permits shall be required. (h) any violation of this section shall be grounds for the revocation or suspension of a permit. 5ec8ef588b
